Terms and Conditions

- 1 These terms and conditions are for all entrants who enter the ‘Black Friday Spin and Win’ Promotion (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2 The Promoter is ISPT Pty Ltd (ABN 28 064 041 283), trading as Wagga Wagga Marketplace (ABN 37 002 851 925), Baylis Street, Wagga Wagga NSW 2650. Phone: 02 69 317 277. Authorised under TP/03031.

ELIGIBILITY

- 3 This Promotion is only open to NSW residents who are 18 years old or older.
- 4 The following persons are ineligible for the Promotion: (i) directors and employees of the Promoter, its related companies or any of its agencies or retailers and staff that are associated with the Promotion (ii) the spouse, defacto spouse, parent, child or sibling of an aforementioned excluded person; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
- 5 One entry per person per single spend.

PROMOTION PERIOD

- 6 The Promotional period will occur daily from 10am to 2pm between Friday 24th November and Sunday 26th November 2023.

HOW TO ENTER

Employees of Wagga Wagga Marketplace and their immediate family, tenants in the centre and their immediate family, the staff of tenants in the centre and their immediate family, the proprietors and staff of companies involved in the production, publishing and administration of this promotion and their immediate family are not eligible to enter. Immediate family means parents, siblings, spouse, children and grandparents. Tenants means lessees, licensees and in the case of a corporation, their directors.

INVALID RECEIPTS

- 1 The following receipts are not valid receipts for the purpose of the Promotion: (a)

receipt(s) from non-participating retailers (b) receipts from click and collect or online deliveries; (c) receipt(s) recording bill payments and prescription medicine, (d) receipts recording Layby payments except where a Layby is finalised and payment completed during the Promotion Period; (e) receipts recording redemption of gift card purchases, store credit, refunds and exchanges; (f) ATM receipts and (h) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts. The same purchase receipt can only be submitted once in the Promotion. The Promoter reserves the right to stamp and/or photocopy each purchase receipt submitted in the Promotion before returning them.

GENERAL

- 2 Promotion continues until end of promotion period.
- 3 Incomplete, indecipherable or illegible entries will be deemed invalid.
- 4 If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole and absolute discretion, to determine the identity of the entrant.
- 5 Redemption of the prizes for any good or services are subject to the standard terms and conditions of the relevant providers. If for any reason a winner does not take the prize or an element of the prize at the time stipulated, then the prize or that element of the prize will be forfeited.

- 12 If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole and absolute discretion to the fullest extent permitted by law to: (a) disqualify an entrant; or (b) subject to any written directions from

a regulatory authority, modify, suspend, terminate or cancel the Promotion, as it deems appropriate.

- 13 The Promoter's decision is final, and no correspondence will be entered into in this regard.

- 17 Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including their respective directors, officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter; (d) any variation in the prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or winner; or (f) use of the prize.

PRIVACY
